

#### Foreign Languages Policy

This document is a statement of the aims, principles, strategies and procedures of Foreign Language (FL) teaching throughout the school.

#### Rationale

We believe that every child should have the opportunity at Corsham Primary School to study a foreign language to enable them to learn about, and foster an interest in, another language and culture. This will enable them to develop their confidence and skills in another language, a skill which is increasingly valued. The teaching of MFL will also contribute to their literacy skills and raise awareness of other cultures through intercultural understanding.

#### Aims and Objectives

- To enable all children to understand and respond to Spanish
- To encourage all children to speak Spanish with fluency and spontaneity
- To develop all children's accuracy of their pronunciation and intonation of Spanish
- To develop all children's ability to write in Spanish for different purposes
- To discover and develop an appreciation of a range of writing in Spanish

# Meeting Our Aims

# Teaching and Planning

In order to achieve our aims we will:-

- · Follow the school scheme of work.
- At Foundation and KS1 Spanish will be introduced informally and linked to other areas of the curriculum.
- Simple vocabulary and phrases will be introduced and built on year by year.
- Teaching is supported by the school Scheme of Work which outlines lesson plans as well as providing flip charts, songs etc.
- Teachers will be responsible for the weekly planning and timetabling of their class MFL teaching.
- Teachers will be supported by the MFL leaders in order to deliver the scheme of work.

# Assessment and Monitoring

- Assessment is undertaken in accordance with the school policy and assessment opportunities are identified and carried out by the individual class teachers.
- Teachers complete Traffic Light assessment records in the summer term.
- Assessment data is kept by the MFL leaders so that progress of classes or year groups can be tracked. Areas for further development and improvement can be identified.
- Teachers are responsible for handing on their class MFL data to the next class teacher to ensure a smooth transition. This is particularly important while the Scheme of Work is being established.
- MFL co-ordinators will establish a subject portfolio to provide evidence of progress and levels of attainment throughout the school.

#### National Curriculum

There is no statutory requirement to teach a foreign language at Key Stage 1. A
foreign language is compulsory at Key Stage 2. The school scheme of work is
within the Department of Education guidelines.

#### Success Criteria

- Evidence of Spanish will be visible in every classroom through class displays.
- Fortnightly Spanish lessons or blocked learning linked to topic.
- Spanish will be evident in other areas of the curriculum, for example the role play Spanish café.

Teacher assessment and pupil conferences will indicate that pupils:-Have some knowledge of a Spanish speaking country and its culture...

- Have a positive attitude towards learning Spanish
- Have some knowledge of a Spanish speaking country and its culture.
- Can independently remember some Spanish vocabulary appropriate to their stage and enjoy having a go at using it.
- Can independently use some simple language structures appropriate to their stage.
- Have a positive attitude towards continuing to learn a foreign language in the future.
